I have more than 35 years' experience in the development and management of protected areas in Lebanon. I have worked extensively with the United Nations Development Program-Country office, the Lebanese Ministry of Environment, and non-governmental organizations. I am one of the founders of the Lebanese Environment Forum (LEF), an umbrella organization that encompasses more than 40 NGOs working in environment and development fields. Positions held were President of LEF, SPNL, manager of Al Shouf Cedar Reserve (largest reserve in Lebanon), and initiated six Himas(community-based protected areas) in Lebanon between 2004 and 2006. Technical advisor to Ministry of Environment on hunting related issues, and finally expert in project development. Recently, I have been nominated as a member of the Global Council in BirdLife International, and Middle East chairperson, Coordinated the IUCN Sailing to Barcelona on behalf of the Middle East and Central Asia member countries. Helped Found the Hima Fund, and elected Hima Fund Board Member. I am currently in charge of the programs and projects of SPNL, where my position is Director General.

As a founding member and vice president I volunteered with SPNL from 1984-2002 in the fields of members' mobilization, awareness campaigns, strategic planning, fund raising, and link with national and international NGO's and governmental organizations.

I have participated in the production of several publications, posters, pamphlets, leaflets, and 5 books; some of which include: Field Guide Birds of Prey in the Middle East, Educator's Guide Services, Wild Mammals of Lebanon, Field Guide to the Birds of the Middle East, A Field Guide to The Mammals of the Middle East, etc. Moreover, my articles on the need to establish a National park system in Lebanon and categories of protected areas helped move forward the understanding of nature conservation in Lebanon. As such I promoted the establishment of several NGO's and a number of Nature Reserves in Lebanon, and secured funds for their operations. I have helped in designing the project proposals for the protected areas in Lebanon that attracted 2.5 million US\$, a first of its kind project for Lebanon. In November 2002, I became a full time staff as Director General of SPNL, and the Important Bird Areas program in Lebanon.

As a founding member of the Society, I have helped define its aim and goals, etc. and I am a member of its executive committee. I have trained and managed a Reserve Team of 13 rangers, guides, scientific and awareness officers. I have contributed to the preparation of several awareness publications for the reserve, and was especially involved in the production and training on the reserve management plans. I have ensured liaison with 13 municipalities surrounding the Nature Reserve, and drafted the MOU with the Al-Shouf Cedar Society, governmental agencies, and international organizations. My work entailed many other responsibilities that assumed the financial sustainability of the staff and the Nature Reserve.

## Lebanese National Hunting Council (LNHC) (1984 to 1996)

When I worked at the LNHC, the production of awareness publications especially on wildlife increased tremendously. As an example these include: Game species (produced a book on the Game Birds of Lebanon and the Middle East). I have conduct lectures, seminars, talk shows, etc... at schools, universities, public meeting, Radio & TV. I have coordinated activities and projects for Game birds with municipalities and governmental agencies and represented the LNHC at national, regional and international conferences.
