- ❖ 1354 local beehives donated to trained bee farmers with women receiving 2 each and men 1 each

- ❖ Each woman train receives 2 beehives while men receive because bee farming is considered a masculine activity
- ❖ Creation of a Honeyshop in Bamenda where honey, bees wax, beehives, bee suits, smokers are made available to bee farmers

- ❖ Trained 142 youths as entrepreneurs in honey-value-chain development.
- ❖ 42 youths/women trained on honey juice, honey wine, candles so that they could transform their forest resources to locally needed basic items and use
- ❖ 74 youths/women trained on using beeswax to produce powder soap, soap, candles. so that they could transform their forest resources to locally needed basic items and use
- ❖ CAMGEW organised bee farmers to cooperatives with women allocated 30 % and youths 30% of leadership positions in 6 cooperatives
- ❖ CAMGEW reorganised 7 community forest management institutions with women allocated 30 % and youths 30% of leadership positions
- ❖ CAMGEW created suggestions boxes, notice boxes and open community radio programmes to gather the comments of community members on what can be done to conserve the forest better
- ❖ CAMGEW created 2 multi-stakeholder platform where forest issues are discuss by all forest stakeholders including forest users like bee farmers and decisions made.
- ❖ About 3300 *Newtonia camerunensis* trees planted in Kilum forest. This is an Endangered Tree specied listed in IUCN Redlist.

Emmanuel has also been thinking of how to make his activities sustainable and has been working on the following:

- Sharing knowledge/experience through fieldwork and exchange visits with various organisations, bee farmers and cooperatives on apiculture and honey value chain development
- Training trainers-of-trainers and promoting beehives from local materials so as to reduce dependency on external materials that could be expensive.
- Use of local consultants in training/coaching so that they are available locally to help their communities.
- Organising exchange visits between honey cooperatives, bee farmers and groups has been institutionalized
- The Honeyshop becomes a demonstration centre for research, learning and marketing of honey, bees wax, and apiculture equipment.
- Sharing knowledge/experience with bee farmers in other parts of Cameroon
- Working with bee farmers to plant trees individually in the forest where their beehives are found to increase bee forage
